**Resolved:** The counseling team was pressed to talk to the parents and resolve this issue with the first year students. The mentoring team was pressed to resolve this with the higher semester students. The HoDs would monitor the course coverage by the end of the month and take corrective steps if required (such as extra classes etc.)

The IQAC team visited the hostels to check for student engagement in self-study during non-academic hours.

#### 5.0 Review of Student feedback

Student feedback received through NIS, class teachers, examination section, dropbox, email were discussed. The following issues were discussed and resolved.

 Due to missed classes and reduced rigor during COVID time, the students were facing issues related to concepts in the classes.

**Resolved:** The hostel superintendent shall assign faculty members (preferably first year common subject teachers) on rotation to go on hostel visits and conduct counseling and doubt clearing sessions.

(Action: Hostel Superintendent)

Student turnout in the placement drives was very low. It was learned from the student feedback
that the gap during COVID has reduced the confidence to face personal interviews and technical
rounds. The students would hesitate to sit in placement drives where there was less chance of
them getting selected.

**Resolved:** The counseling team shall work with the students to conduct multiple inter-personal drills to elevate the confidence level of the students. The Placement team shall conduct special drives to conduct regular GD and mock PI to give some exposure to the students.

#### (Action: NCS Coordinator, PIC Placements)

A few girl students who frequently reported late to the class gave feedback related to monkey
menace. Often around breakfast time, the monkeys would wander in the corridors of the hostels
and they would become aggressive if apprehended. In fear, some of the students could not leave
the rooms till the monkeys did not go away on their own. This was causing them delay in getting
out of the hostel.

Resolved: The hostel superintendent would install square nets to discourage the monkeys from coming to the hostel corridor. All hostel borders would be sensitized not to offer food items to the wild animals which would refrain them from getting attracted.
